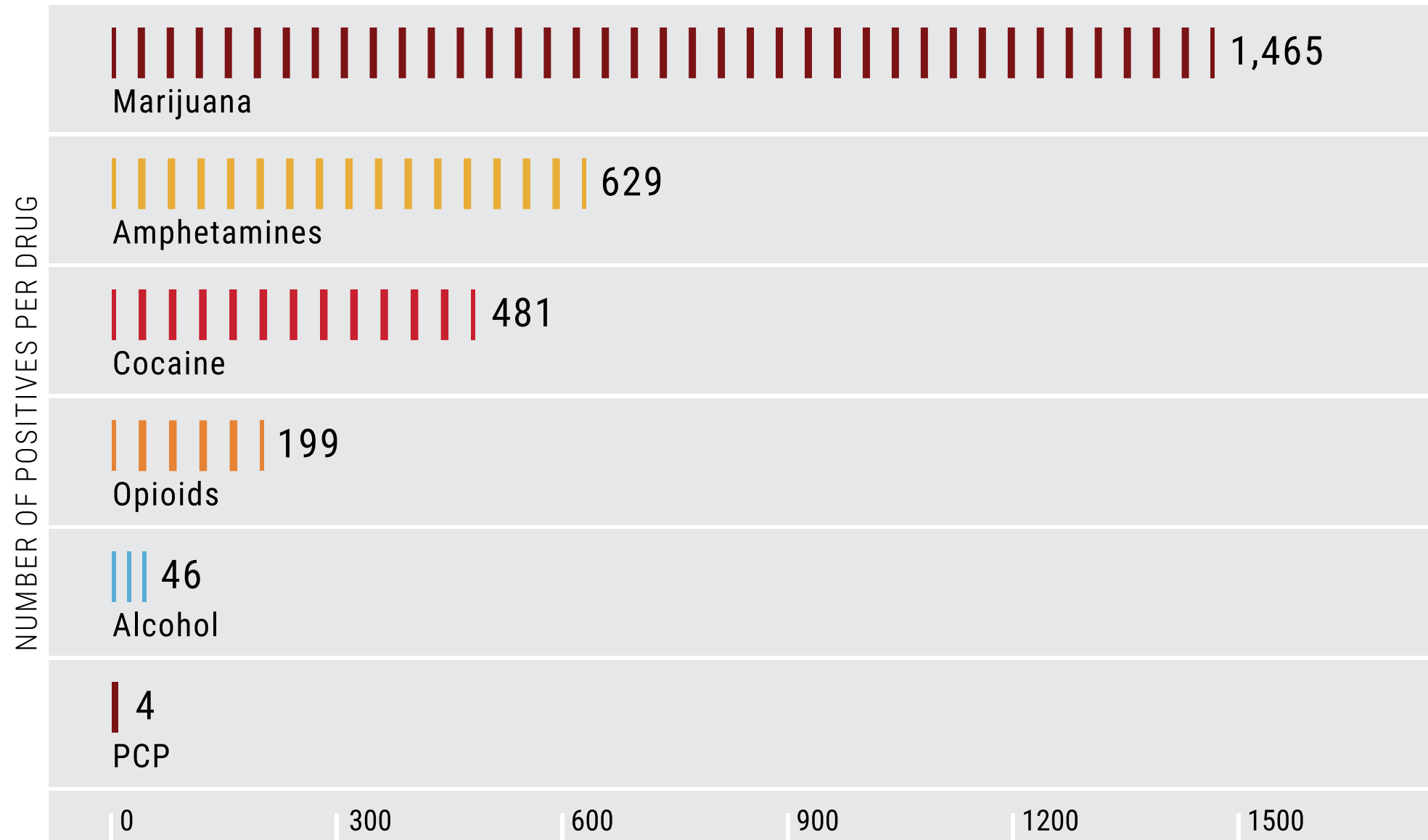

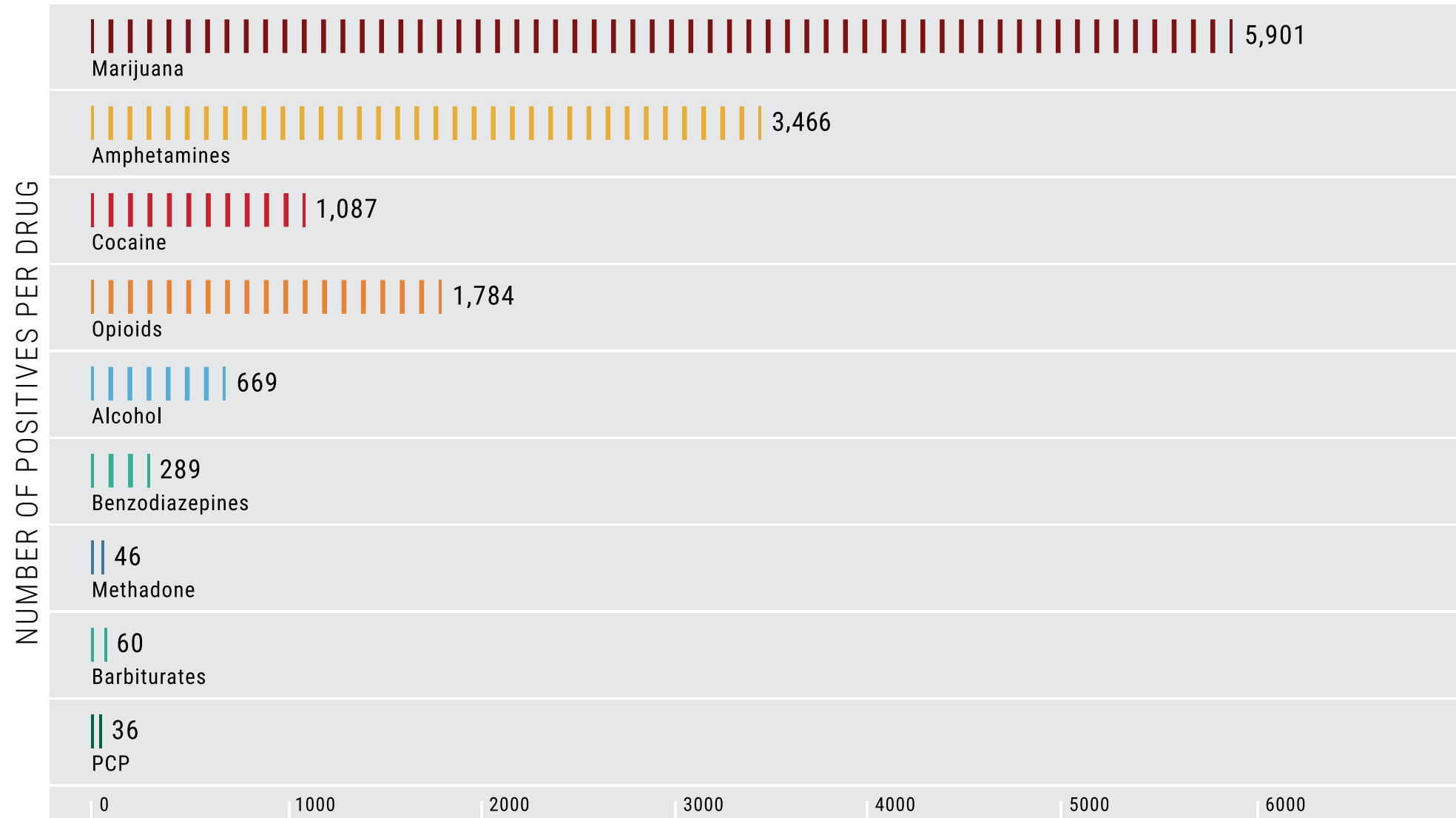

WHY AUDIT ELDs?

Due to manual entry requirements, no log is immune to the risk of falsification, even ELD logs. In fact, one of the most common misconceptions is that ELD logs cannot be falsified, however, due to the requirement of manual inputs into the ELD device itself, nothing could be further from the truth. ELDs record engine activity, but often fall short on recording human activity, such as duty status, roadside inspections, fuel stops, etc., all of which must be supplemented to engine data to complete the ELD log.
